Pursuant to the Joint Motion for Extension of Preliminary Approval Order Deadlines, and upon consideration of the issues discussed with counsel for the Parties on September 11, 2024, it is hereby ORDERED that the Motion is GRANTED. The class action settlement notice and approval schedule set forth in the Preliminary Approval Order shall be modified as follows:



The settlement administrator is directed to update the settlement website to reflect these rescheduled dates and deadlines and to provide notice to the additional class members consistent with this Order and the notice plan that was authorized for the initial group of class members identified in April 2024. Defendants will bear the costs of notice to the supplemental class members.

The Court also orders that the Incentive Award of \$15,000, which equates to approximately 0.54% of the total settlement fund of \$2,800,000, shall be paid to Representative

Plaintiff on or before October 11, 2024. The Court so orders based solely on the consent of the Defendants to effectuate this payment as fair and reasonable and the representations by Plaintiff's counsel that the payment will not diminish or otherwise affect the total settlement fund of \$2,800,000 (as reflected in the Joint Motion for Extension of Preliminary Approval Order Deadlines and as stated on the record on September 11, 2024). This order does not in any way represent that the Court has made a final decision on whether the settlement is fair and reasonable, which issue will be decided at the fairness hearing. The settlement administrator is directed to follow the procedures set forth in the settlement agreement to effectuate payment of the Incentive Award on October 11, 2024.
